



3. Students will receive question paper in word (.docx) format from the concerned email ID mentioned above? 15 minutes before exam. Students shall type their responses/answers in the word (.docx) file sent to them.
4. Students shall write their name and enrolment number on top of the word (.docx) file.
5. On completion of paper, students will be given additional 30 minutes to send the answer book back to the concerned email ID.
