The debut collection presented by the Pink Label Congo by Hanifa was extraordinary, with its 3D virtual exhibition, which merged the concepts of digital and real. This was followed by the 3D holographic model figures on the runway supported by augmented reality by fashion houses like Mugler and Angel Chen.

## Walk With The World-BRACE

# Curvy Shapes- An Interior Trend For 2020 & Connection To Science

Merriam-Webster defines a trend as, “the general movement over time of a statistically detectable change”. Interior trends change every year based on the varied opinions of designers, clients and the Worth Global Style Network (WGSN). Curvy shapes in interior spaces have captured the attention of all around the world. A throwback, retro style from the 60s and 70s being adapted to modern furniture, allows varied sources to attest to the look of interiors improving with curvy shapes - through furniture, accessories and basic architectural elements.



Curves make the interior space, inviting and comforting. It invokes a feeling of calm, harmony and warmth, creates a focal point and allows the eye to flow (McKee, 2014). Curves used with modern architecture assist in softening “sharp edges and sleek lines” (Sniraite, 2019). These lines, shapes and forms in furniture break the rigid and monotonous flow of a room. Feelings of integrity, power, femininity, grace are evoked with the appropriate usage. McKee in borrowing from Bronwyn Poole of Touch Interiors stated that a constricted space infused with curves conjures softness and visual flow to the room (McKee, 2014). An automatic shift in energy is seen when curved furniture is placed in a room. Studies show that sentiments of relaxation and hope are axiomatic through curved furniture compared to “hard-line alternatives” (Son, 2019).

Sinuous furniture pieces create a conducive environment for conversation. Contoured furniture allows for conversation without lines blocking your view. Not only does the furniture improve communication flow, but also improves posture and prevents body contortion prevalent in sleek furniture (Son, 2019).

Circles, ovals, ellipses, half-circles, arcs, oblong-shaped, looping and amoeba-like furniture are being incorporated into all forms of interior spaces – building components such as walls, windows, arches – as well as furniture and accessories. Provision of a natural, organic feel through the furniture creates visual, captivating elements. Principles of design such as asymmetry, harmony and emphasis are tick-marked through arched furniture. Mix-matching with geometric prints, patterns create alluring visuals.

McKee in borrowing from Poole states that, if used correctly, curves conserve room and the fundamental aspect is to consciously maximise the benefits of the curve. Evidence in a study states that participants were likely to consider a room with curvilinear forms as beautiful, compared to linear forms. The researchers observed brain activity while viewing the pictures. Results showed that activity was highest in an area called the anterior cingulate cortex; the most important cognitive function being the involvement in emotion. Another study regulated by Moshe Bar of Harvard Medical School stated that looking at sleek lines and pointed edges spikes the amygdala – the part of the brain that processes fear. Sharp objects have been associated with fear, whereas curves are considered harmless. Curves signal a lack of threat and evoke emotions beyond understanding. It ticks a fundamental human emotion which cannot be explained by a basic analysis or test. In conclusion, curved furniture evokes a sense of calm, comfort and balanced spaces. Medical sources support this and give weight to its presence in the list of major interior trends of 2020.

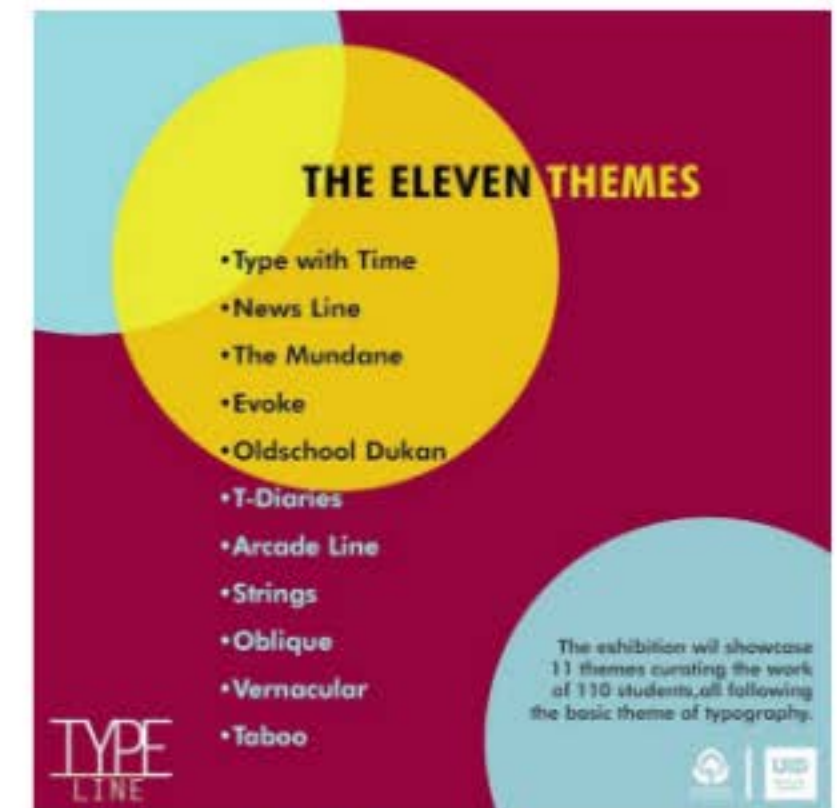


## TYPELINE – An Experience

The year was a definition of pain, loss, isolation and striving to live and be alive for the next day. Amidst all this chaos, the world as a whole introspected. We took a pause and addressed issues. We learned how to be alone with our thoughts, without distractions and understand the nuances of our daily life. Everyone found a way to unwind at home and find the small joys in the world which were falling apart.

If someone had told me that I would be beginning my Master's degree in the middle of a world-wide pandemic, and enjoying it, I would've laughed and just completely brushed them off. .....I learned drafting and how to draw plans and sections of my bedroom through a computer. It was extremely hard to form a pathway of proper communication and it took some time, but I figured it out. There were days I craved the feel of sitting in a classroom with my peers and learning all the skills with real-life people, but those moments passed and I had to accept that this was the way it would be and all I could do was wait till it got better. Assignments were thrown like frisbees and there was no time at all, for anything but work. There were new submissions, discussions and things to learn every day. Around a month into the semester, I started my first ever interior design project – the final semester residential design. I did not know that the process was so gruelling, till I started working on it. There were various things to be done and not enough time to do it. Curating an entire client profile and then designing a house for that set of people as a third person was one of the best things I have done in a very long time. I learned software which I never thought I would and enjoyed it. I sketched, drew, made mind maps, understood the importance of space planning and managed to get a design in place. ## Walk With The World- Hand In Scan

Hand-in-Scan ZRT. in collaboration with Supercharge and Flying Objects has used the influence of facility design to address the problem that healthcare employees are facing to use the scanner as a teaching device for good hand sanitation activities. In order to improve and calculate the hand hygiene of medical workers and to reduce the number of deaths caused by hospital infections worldwide, Hand-in-Scan launched its pioneering health-tech approach. It has created its ground-breaking scanner - an AI-enhanced UV detection scanner, which won the IF GOLD AWARD 2020 for the Service Design category and the REDDOT 2020 for Interface Design category.



Hand-in-Scan is an invention focused on poor statistics found in Hungary. Thousands of people die every year, in developing countries, from nosocomial infections prompted by insufficient hand disinfection of healthcare staff. Hand-in-Scan uses artificial intelligence technologies to use innocuous UV and optical imagery. The self-designed software can accurately differentiate between hand surfaces disinfected by the contaminated and quickly track details. The configuration of both the shape and interface facilitated to the users, a simple and intuitive operation of the unit. The key to the popularity of this product is that architecture and innovation have come together. Furthermore, longevity and ergonomics were critical.

The Hand-in-Scan prototype has been successfully tested on more than 15,000 people in the health staff.

# Cryptocurrency In India

The world started losing the trust they put in various financial participants such as the bank and the government during the 2008 financial crisis. This meant that people all over the world were more in favour of digital currencies than ever before. The idea of carrying out transactions without involving a third party such as banks and government institutions felt intriguing.

Bitcoin was introduced as a currency. It is backed by a technology known as 'Blockchain'. The very idea that there is no requirement of a third party to authenticate a transaction enables peer-to-peer transfer of money. This is the very idea behind

The three factors that made blockchain popular are as follows:

1. Peer to peer transfer of money thus discarding the need of having a third party such as banks.
2. The ability of the technology itself to authenticate transactions makes it trustworthy.
3. All bitcoin transactions are traceable, public and are stored permanently in the bitcoin network.

## How are cryptocurrencies different from the currency we use in our day-to-day life?

The currency that we use regularly is known as fiat currency. It is a legal tender that has been recognised by a government, state or country.

However, cryptocurrency has not been accepted as legal tender in India.

Cryptocurrencies if properly regulated can function like the fiat currency that has the following functions:

- It functions as a medium for exchange
- It has value
- It is used to settle debts
- It is used to account transactions



## Future of Cryptocurrency in India

It is important to note at this point that the landmark judgment only invalidated the 2018 circular by RBI. Banks and other entities under RBI cannot deny banking and payment services for virtual currency activities. However, the judgement does not provide/indicate the regulatory provisions needed for cryptocurrencies. Currently in India cryptocurrency remains deregulated. This is a roadblock in the path towards growth and proliferation of the industry. It is important for business, exchanges, investors, traders etc. of virtual currencies to know where India stands in order to effectively carry out practices.

A draft bill titled 'Banning of Cryptocurrency and Regulation of Official Digital Currency Bill, 2019' (Draft Bill) was prepared on 2 November 2017. This bill has not been introduced in the parliament yet.



# The legal framework around cryptocurrencies in India

Cryptocurrencies are not regulated in India. India has not been very open to the idea of cryptocurrency being used in day to day life. This is evident by a circular that the RBI came up with in the year 2018. The said circular prohibited banks and other financial institutions from providing services to easily deal in virtual currencies. This action discouraged those who invested in cryptocurrency and also demolished the business models of cryptocurrency exchanges that were functioning in India.

In the landmark case of *Internet and Mobile Association of India v. Reserve Bank of India*, the Supreme Court of India struck down the circular passed by the RBI. This judgement potentially altered public opinion towards cryptocurrency. This judgement had a significant impact on the crypto industry in India because the 'Proportionality test' required to constrain trade practices under the Indian Constitution proved to be negative:

One of the grounds for challenge was that the RBI circular fails to pass the proportionality test under Article 19(1)(g) of the Constitution of India (Constitution) which guarantees to all Indian citizens the right to carry on any occupation, trade or business.

The SC observed that the 2018 circular does fail the proportionality test as:

1. Even though virtual currency was not banned in India, the circular prohibited traders from accessing the services of financial institutions.
2. The RBI could not establish any wrongful act carried out with the help of cryptocurrencies.
3. No RBI regulated entity had suffered harm by indulging virtual currency exchanges.



The SC also observed that:

Cryptocurrency traders and investors have other financial resources to turn to. However this is not the case for cryptocurrency exchanges as they do not have any other means for sustenance.

Even though there was not enough evidence that cryptocurrency exchanges have a negative effect on the entities regulated by RBI, the circular crippled these exchanges by restricting their access to banking and payment routes.

The court observed that since cryptocurrency is not banned in India, it is disproportionate to deny access to banking and payment routes.

## A Conclusion

It is clear from the above discussion that India has been strict and discarding in its approach towards cryptocurrencies till now. However, the benefits of cryptocurrency industry cannot be ignored. The industry has grown over time and can provide benefits if regulated properly.

The landmark judgement only provided temporary relief as the bill still looms as a threat to the industry if passed. A regulatory framework that helps the industry flourish but also considers all stakeholders can help ensure that issues related to money laundering, anonymity, complicated KYC requirements etc. do not rob the users of the benefits of the technology.

India is the largest democracy in the world, and is country where democratic values and principles are followed. ONE NATION ONE ELECTION is basically a vision of the NDA government. In the way ahead, we will discuss how this can this help India to have better administrative function on and what impact will it have on the federal structure of our country. In the larger public interest the idea of ONE NATION ONE ELECTION will be quite useful.

The election process in India is year long. One or the other elections are taking place across the country from time to time, whether it be, Rajya Sabha elections, Lok Sabha elections, state legislative assembly elections, municipal corporation/ municipality elections, Panchayat elections etc.

We are aware of the money spent in the election process across the country by individual candidates or different parties. If all elections go simultaneously then, it will lead to money saving by the central government and also in respect to different political parties and individual. It is a known fact or an open secret that election- to what I believe are fought, by some on black money. This system will keep a check and prevent that from becoming a parallel economy.

During elections government appoints many agencies, high manpower machinery, and security for smooth functioning of the election process in the country. If India follows this system it will have a huge saving and everything would happen in one go.

It has to be observed that when elections are held once in five years, it will reduce governments accountability towards people. As it is correctly said, repeated elections keep legislators on their toes and increases accountability. Also most importantly when elections have to be conducted simultaneously, presidents rule has to be imposed which will undermine the federal structure and democracy. The merits of this system outweigh the demerits. ONE NATION ONE ELECTION, is not a subject of debate but a necessity for the nation. To conclude, we can say that this type of arrangement will benefit the people at large and also lead to proper administration of the country.

# Role of Dissent in a Democracy

The term dissent has come across us on many instances. But what does that actually mean? Do we actually have the right to dissent or disagree?

Dissent means to have a different opinion, philosophy, thinking, or a sentiment of non- agreement with an existing idea or a policy enforced by some authority. Disagreeing is a very common trait that humans exhibit all the time. No two people may have the same point of view. Individuals disagree with things- some or other on many instances. In such a diverse country like India people have different views and opinions which also have to be considered.

When there are differences of opinions, new ideas emerge and that in turn help the society to develop.

Right to dissent is an enabling right. It allows citizens to participate in representative democracy.

In connection with the arrest of academicians, human rights activist, journalist in reference to the Bhima-Koregaon violence the Supreme Court said that dissent is a safety valve of democracy. If the safety valve is not allowed to function- then the pressure cooker will burst. The preamble of our constitution guarantees liberty of thought and expression but also categorises in the broad sense that it should not harm the unity and integrity of our nation. Also, Article 19(1) fundamentally guarantees freedom of speech and expression, freedom to assemble peaceably and without arms, and freedom to form associations and unions.

A government that is committed to dialogue and the development of a country in a more holistic manner should welcome dissent and if they do not they are not truly said to be the representatives of the people. According to Justice D.Y.Chandrachud the blanket labelling of dissent as 'anti-national' or 'anti-democratic' strikes at the heart of our commitment to the protection of constitutional values and the promotion of deliberative democracy. He also emphasised that the true test of democracy is its ability to ensure the creation and protection of spaces where every individual can voice their opinion without any fear of retribution and also elected government cannot claim monopoly over values. Also in the parliament, voicing opinions and views by the opposition parties are of great importance. They help the government, to make important amendment in existing laws and policies or to bring in new policies. Justice Chandrachud also stated that suppression of difference and silencing of popular or unpopular voices that offer alternate views is a great threat to the pluralism of our country.

There has to be a distinction between legitimate dissent and a dissent which breaks down or tramples the unity and integrity of a nation. Legitimate dissent is an indispensable part of a democracy as it enhances public participation in legal and policy related matter.

When do protest on some issues happen? To the best of my knowledge they happen when there is dissent or disagreement on any said issue.

Protests are also important in a democracy and help the public to express their opinion on various issues concerning the country.





When we consider the farm bills, now assented by the president and the protests revolving around it, it lays out a clear expression that the government is allowing people to protest in that particular case. But when we examine that carefully, we know that these protests are not violent in nature. Until and unless a protest is violent in nature, or undermines the unity and integrity of a nation it is a legitimate and democratic dissent. The right to peaceful protest is a fundamental right guaranteed by the constitution.

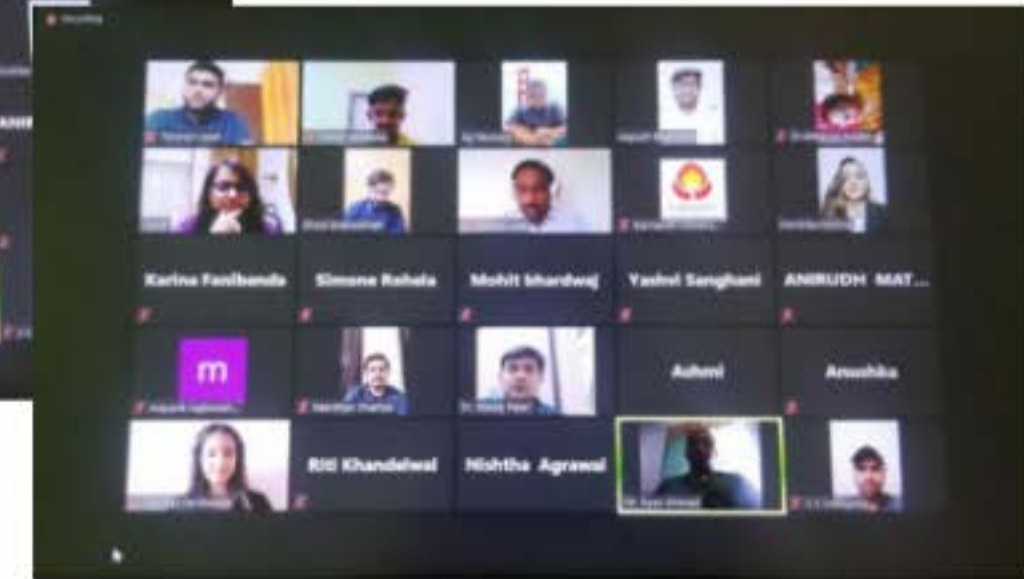

Recognizing the complete shutdown of courts, the justice system turned to technology for solutions.

The apex court of India through an order, set guidelines for utilising Video Conferencing and measures to be taken in order to reduce physical appearances in courts to successfully practice

## Virtual Courts before Covid-19

A two-judge Bench in *Krishna Veni Nagam v. Harish Nagam* allowed the use of video conferencing tools in order to hear the matter. This was due to the fact that the litigants were living away from the local jurisdiction.

Delhi's first virtual court was launched on 26th July 2019 at Tis Hazari Court. The Punjab and Haryana High Court also launched a virtual court on 17th August 2019 at Faridabad.

This court deals with matters related to traffic challan.

The e-committee of the Supreme Court of India has played a major role in enabling online justice delivery.

To enable technological advancement in Indian courts, the "National Policy and Action Plan for Implementation of Information and Communication Technology (ICT) in the Indian Judiciary-2005" was formulated by the e-committee of SC of India.

The above information proves that technological advancements were slowly and gradually being adapted. This pandemic has accelerated and catalysed the technological advancements of court systems in India.



## Benefits of Virtual Courts



Following are the benefits of virtual court hearings that have been highlighted during lockdown:

1. The virtual court system is hearing the most urgent matters.
2. The e-filing process is open for all types of matters.
3. This system enables both the delivery of justice and social distancing practices.
4. It reduces the cost of infrastructure, security, staff etc. as in-person court sessions are suspended.
5. It makes hearing of cases easier for people who are not living near the court. It reduces the cost of travel for counsel and clients both.
6. It enables people to seek justice who otherwise hesitate due to financial problems, physical disabilities etc.
7. Since the time to resolve cases is reduced, it can help to accelerate the justice delivery system and reduce the number of pending cases.
8. The apex court in the case of *State of Maharashtra vs. Dr. Praful Desai* stated that the meaning of the word "presence" under Section 273 of CrPC is not confined to the "actual presence of a person" within court premises. Advanced technology can be used to record evidence and obtain statements remotely. This encourages people who otherwise would not agree to come to court because they don't want to be caught up in court matters or sometimes fear for their life.



## A Conclusion

Availability and accessibility are the two core values of the Indian Justice system. Due to the global pandemic both of these values had been compromised. This pandemic has proven to be an opportunity for the Indian courts to rapidly move towards digitisation. Justice delivery should not be confined to the brick rooms of courts. This has been proven right by the Indian Justice system by hearing and deciding cases during lockdown. The promise of justice in India crosses physical boundaries and ensures that timely-delivery of justice takes place.

There are many practical problems that have been experienced in the process of using video conferencing. Lawyers as well as parties have highlighted the problem of lack of technological resources. Technology is not accessible to all in India. Lawyers and people who hail from humble backgrounds tend to experience technological inequalities as they are not able to afford resources such as a smartphone, a sound internet connection etc.

Thus, it is a challenge for the courts now to ensure that digitization of the justice system progresses in a way that it overcomes the technological and economic barriers of this country. It would encourage more people to approach courts as the degree of accessibility increases. Creating a smooth-running and affordable digitised justice system would revolutionise how justice is delivered in India.

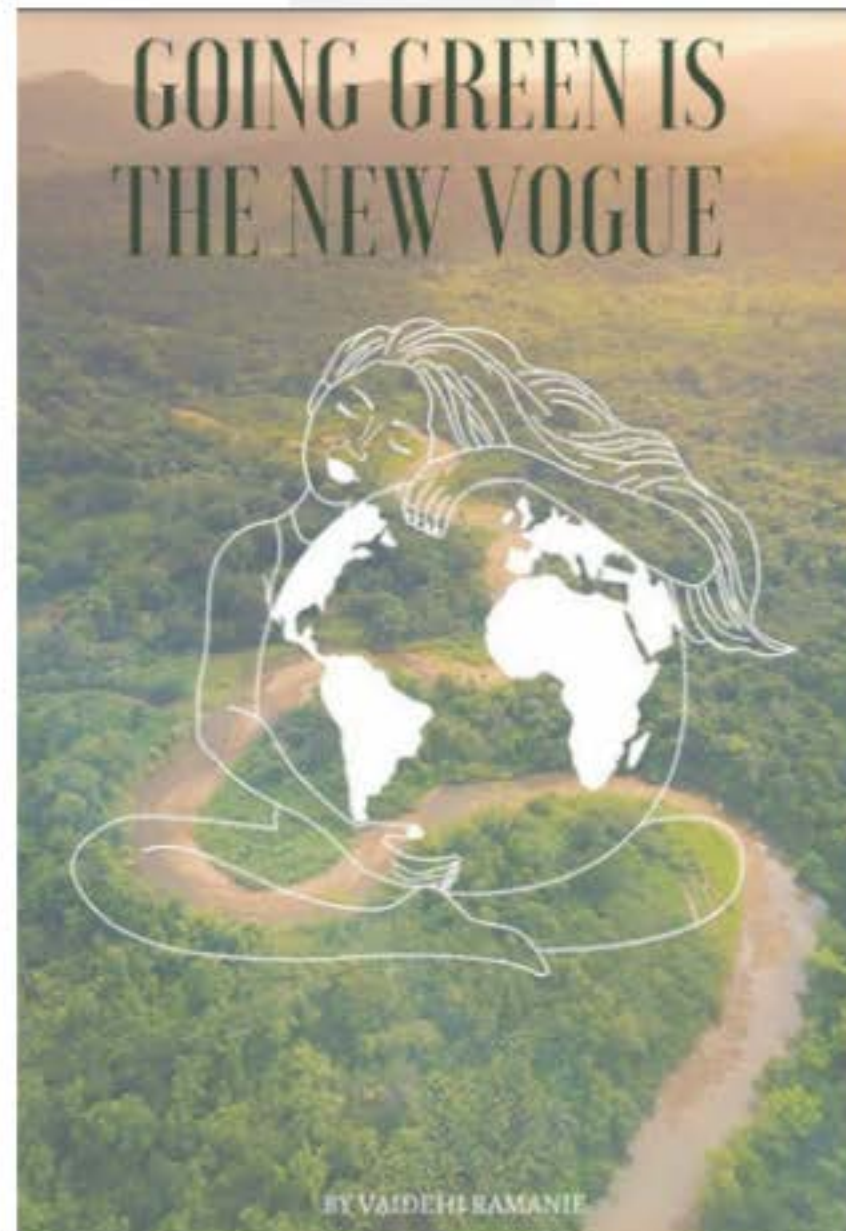
# Going Green is the New Vogue

# LIBERAL ARTS- A WAY OF LIFE

Lenses of the Liberal Arts: How we identify, analyse and understand the world.

A discipline hones an individual with knowledge and stipulated skills vital for a particular profession. Although it is essential as to what extent a discipline, beyond its curriculum, can mould an individual's life. Liberal arts as a discipline, in its womb, conceives numerous fields of knowledge to ultimately give birth to a new way of life, instilling an individual with core soft skill attributes of creativity, communication, collaboration and critical thinking. Prosperity and evolution stand on the shoulders of perseverance, it asks for adaptability against agileness and uncertainty of life. The subjects embedded in this discipline aim to refine a student's research, writing, critical thinking skills and it teaches you how to learn, how to form and evaluate effective arguments and experiences. It cultivates them for a broad range of careers in contrast with disciplines that may prepare an individual for a particular profession. It's a way of life that adorns you with knowledge and critical thinking. It exhorts you to stretch your horizons beyond a stipulated profession and to encroach your scope for the abilities and skills which opens a huge array of prospects in the job market, including in STEM (science, technology, engineering and mathematics).



The history of liberal arts traces its existence earlier than the middle ages, the period of classical and other human civilizations. Derived from the latin word 'liberals' which means "appropriate for free men." Ancient Greeks and Romans perceived liberal arts education essential for a human being to be free. Moreover not all the citizens deserved to study liberal arts which underscored civic duty and the development of the whole human being to their full potential through the study of grammar, rhetoric, and logic. While vocational and technical studies were meant for non free members of the society, which implies for slaves. Fundamentally, the main goal of liberal arts was to educate people about civic life and subjects around the same, to strive for a holistic development as a human being by honing them for a broad range of subjects and topics. Modern liberal arts education, too, reflects the principles of holistic development by focusing on a range of subjects in the arts, humanities, social sciences, science, and mathematics.



Liberal arts as a discipline is a cognitive way to view the world in distinctive hues via four noteworthy lenses. These lenses essentially accommodate a pupil with a rational and refined perspective, with a potential to emerge as an asset for one's country and humanity, strengthening one's social and cultural critique. It is significant to note that each lens has its own attributes and thus it caters an individual to examine the same topic in different ways. The four lenses are generally perceived as:

## 1. The Humanities:

Globally this field comprises numerous disciplines like english, history, philosophy, religious studies, ethnic studies, etc. Humanities basically examines and explores the process of how humans perceive, understand and represent their experiences via numerous ways of human expression like literature, history, fine arts, dance, photography, philosophy. Humanities broadly aims on objectively examining and exploring different cultures around the world, the differences and similarities in the values these cultures have to offer. It also cater students to investigate historical arts and artefacts while pondering on the questions like, "how do these art forms were created or what do they represent about the culture of that time?" Humanities further examines the human experience, the cultural and social values from both history and present. In the wise words of Dr. Carol Geary Schneider, "Humanities help us explore the values that matter to us as a society and as individuals."

## 2. The Social Sciences:

This field of study in its most basic sense, is traditionally defined as "The pursuit of the true nature of society and human beings." It unravels the nature of society and human beings through the paths of political science, psychology, sociology and anthropology. It broadly asks questions like "what does it mean to be human?" "what defines a person?" It investigates our relationships and interactions with people around us. When talking of social sciences it is critical to think are they our thoughts or interactions with people around us, or is it our location, geography that makes a human what he or she is? It is about understanding how people live and how to improve our lives. Social sciences also overlaps with the lens of history to examine the social relationships in the past. It, moreover, focuses on interactions and aims on promoting better living.



## 3. The Natural Sciences:

# POP CULTURE INFLUENCE ON BODY SELF IMAGE

From Madonna to Rihanna, the idea of the “perfect body” has been an ever-evolving concept. The only constant has been the criticism and judgment that follows. From chubby to skinny to curvy, or from abs to dad bods, we frequently come across different conceptions of what we consider the ideal body type. What we often fail to consider, however, is how these unrealistic expectations and distorted perceptions take over people’s confidence and self-esteem.

Popular culture and social media platforms have given rise to an extremely unhealthy culture of promoting the idea of a perfect body, which is nothing more than a myth. A model posts a picture on Instagram, millions of young girls view it, and do not conform to the “idealistic” bracket the picture creates. They pick up a magazine, the first article they come across is “how to lose 5 pounds in a week”. No matter what movie they pick, the protagonist is a beautiful, tall, skinny goddess with great hair and glowing skin. These false images and portrayals cause severe consequences on young women’s physical and emotional aspects, negatively affecting how they perceive themselves, and how they measure their self-worth. To achieve their quixotic targets, many women go to extreme lengths and measures, which lead to a number of health problems and eating disorders. In a one-year period stretching from 2018 to 2019, an estimated 10,200 people died as a direct result of eating disorders, and the number of eating disorder cases is projected to increase by 5% over the next decade. Other health issues, including heart diseases, diabetes, high blood pressure, and even strokes, are common repercussions of such practices.

What has been the root cause of this culture of self-hatred and self-delusion? While media and pop culture have played an undeniable role in further accelerating the problem, the foundation lies in the mentality of the people. When Billie Eilish’s famous “wine mom” picture was leaked, there were innumerable negative comments, trolling and shaming an 18-year-old. But worse than the haters were the people who, in her defense, called her “brave” or “courageous” for wearing a tank top. When you say that someone was brave to wear something “despite” their body size, you’re expressing the belief that certain clothes are not meant for certain people, and that choosing to wear something you feel comfortable in is a bold move if you don’t conform to the traditional standards.....





.....How does this prolonged cultivation of insecurities and condescension come to an end? Simply telling people to accept themselves and be resilient in the face of the bombardment of images promoting the thin ideal can be damaging. Telling people to ignore the dominant beauty ideal isn't realistic. It can create more pressure for a person who is already feeling anxious, negative, and devalued. Popular culture tells people that they are flawed—but then demands that they have a positive attitude about it. Not feeling positive about your body can then lead to shame and guilt.

The body positivity movement in its current form began to emerge around 2012, initially focusing on challenging unrealistic feminine beauty standards. As the movement grew in popularity, the original focus on acceptance of weight began to shift toward a message that “all bodies are beautiful.” The movement is designed to foster acceptance and love of your body. It cannot be achieved in a day; it's a slow and steady process towards self love and, ultimately, a healthier, happier life. And while simple practices like self-affirmations and body positivity movements might help, a real change will transpire only through a change in our outlook and mentality.

Breathing in its atmosphere for long, you might as well get comfortable to it, ignoring its presence. Take a dip in any streams : medicine, technology, science, arts, education, etc. gender predominantly determines its flow. From roles you play, till how you are treated, it's all about your gender. Perception about gender identities sketches, stretches, shortens the lines of our experience with this world and ourselves.

To understand the role of gender in life, one must understand what gender is. It's a social construct reflecting the social expectation of expression of one's identity, presentation of self-behavior and interaction with others. It's the social category which reflects socially and culturally produced identity. Noticed, how the technological sector resembles an all boys club? The shades of surprise on encountering a tech savvy female. It's the ingredient of gender bias flavoring mindsets and reality.

By 2022 around 4.5 million jobs will emerge in AI and data analytics. However only 26% of females are in the technological battlefield! Is that the number of females preparing for tech savvy jobs? No. Studies point out : number of females enrolling in STEM subjects, exceed who step into STEM jobs. Why do we have this gender gap? The answer is buried in ages of stereotyping, hostile work environment and less opportunities for females in comparison to male counterparts. Technology is seen as the toy of men. AI, handling machines, coding, gaming, developing programs, etc. are seen as interests of males. This trolls males too. The pressure to align with masculine or male jobs is immense and deeply influences them.....



Many of us feel being surveillance to act in accordance to what is perceived to be our gender. This can be fished out from all streams. Every decision we take is part of our gender and how we collectively cultivate it to be.

Surveys and experiments are crucial elements of scientific research. Testing reality calls for equal and accurate representation of all genders in the study. Most surveys and decision making teams have an imbalanced scale of gender. Unfair representation of transgender, gender-queer, gender-fluid , a-gender, bi-gender and other gender identities leads to biased and unfair environment for them. In many cases it can lead to discrimination and mistreatment, demeaning and stripping them from human decency.

For instance, experts from India and Harvard University studied that Indian women suffer gender bias while accessing health care. It extended upon how the mental and physical health of housewives have been consistently ignored and undervalued. The infamous phrase " men don't cry" or the unsaid rule of being " the man" leaves no room for males to express and experiences the vivid range of human emotions.

The case for transgender is even worse. To quote from the Mint :

" There was even a case of a transgender, a victim of a train accident, dying unattended, because for 3-4 hours, doctors could not decide whether to admit her to a male or female ward..... A lot of trans people don't even go to the hospitals for years, unless there is an emergency, say, an accident. They fear going to the hospital because of layers of homophobia that start from the guard to the receptionist to the doctors to lab technicians. "

These examples from technology, medicine and science are reflective of the slightest of how gender plays a role in our lives.

You cultivate your gender identity and your gender identity cultivates you. The actions, treatment, behavior, interactions, roles, situations and consequences, everything is influenced by your gender. Gender isn't just a tick box on your forms, it is identity, expression and experience of self. It shall always be present and will always influence our lives in most unexpected and intriguing ways. What can be altered is, to have better and more positive experience when it comes to gender. That shall come with collectively deconstructing the ways in which we restrict gender.

Starting right from interactions, let the silence be heard and the dehumanizing be silenced. Prejudice, biases, stereotyping be erased and the narration rewritten.

The business started in August but there was a lot of ideation that went on behind the scenes to get the brand to where it is right now.



With an initial deposit of just INR 500, they contacted manufacturers, courier services to figure out the details of the business. After talking to many manufacturers, one agreed to work with them on a full-time basis for their production which takes place in Tirupur, Tamil Nadu. Their warehouse is situated there and shipping takes place all over India with the help of Blue Dart and FedEx. From August to October, they partnered with a website to showcase their products and built up a small fund. This fund is being put towards their own website, which they are developing themselves without any web developers.

They want to expand their product line, which is why the website was a need that came along the way. They take pride in the fact that the majority of the work is being done by themselves.

At the beginning of their journey, they marketed their small business through their family and friends and encouraged them to showcase their artwork and illustrations with the help of The

Funky Chaos. The company uses social media as their main platform for brand awareness and connecting with the customers. Not only does social media help them to increase sales, but also showcase their products, collaborate with influencers, hold campaigns and build a community. This platform helps to drive traffic to the website and gets a lot of work done in a shorter time. With the flexibility to work at their own time it gives the venture a head start.







The ROI through social media is higher than the traditional ones of radio and television, with the only investment being time. Their products exhibit a lot of pop-culture references which is their main focus as the moment. Their goal is to create merchandise and a brand which allows artwork, illustrations and various types of design to grow with them. The company wants to collaborate and create apparels and accessories with captivating artwork. Kabir and Anuprita talk to various illustrators to provide their artwork, which they can showcase on T-shirts and other types of merchandise. This allows small artists to grow, earn money for their artwork, see other people wear and appreciate their art coming to life. This gives The Funky Chaos an edge over other companies, which do not provide the same services, as both the ventures earn money simultaneously and grow their brands. The new website they are working on allows artists to directly upload their artwork and get it printed without the back-and-forth communication. It also provides options to decide various different options for T-shirts, hoodies and other accessories. They have a feature section where they are going to upload photographs of the people who sport their merchandise.

If it's on Instagram, it gets featured on the website. One of their bestselling designs is merchandise featuring the cartoon Rick & Morty. They follow a few policies to avoid shortcuts and getting tempted. The venture tries to maintain their originality and organic atmosphere by keeping an eye on the competitive market, understanding & learning from its mistakes, analysing what went wrong and figuring it out one step at a time. They are new to this environment and learning things every day, which is a continuous process.

The founders speak about time management and understanding priorities.

Hard work and well curated time management schedules helps the busy founders to stay on top of their work and maintain quality in everything they do. They believe that constant determination to get what you want and cross hurdles is not as easy as it seems, but is worth it in the end.

Izhaar has presented Karnavati University in plenty of competitions and come back with glorious victories.



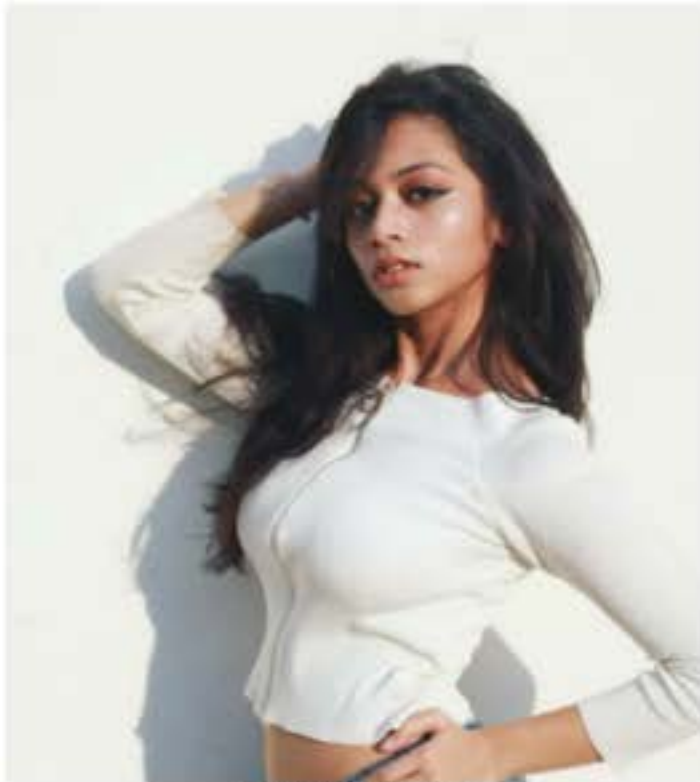
