Subject: Karnavati University - Rules and Regulations for Student Admission Policy (Issue 01 Revision 03)

Karnavati University hereby notifies 'Rules and Regulations for Student Admission Policy' as appended herewith. These regulations lay down the procedure for admission of the Students to the various programs/courses offered by the University to Undergraduate, Postgraduate, Diploma, and research students. This Policy will act as a guiding framework for fair and transparent conduct of the admission of Students. This will streamline and further strengthen the admission ecosystem in the University and achieve the best possible admission outcomes.

This policy comes into immediate effect.

- 1. Short Title and Extent These rules may be called the "Rules and Regulations for Student Admission". These rules and regulations apply to Undergraduate, Postgraduate, Diploma and research students.
- 2. Objective these rules are made in order to achieve the following objectives:
 - i. Lay down the procedure for admission of the Students to the various programs/courses offered by the University and its constituent Institutes.
 - ii. Lay down the eligibility requirements and selection criteria in each program/course.
 - iii. For fair and transparent conduct of the admission of Students.

3. Definitions

- i. "Academic Year" shall mean the period in the calendar year from the month of July to the month of June of following year, during which teaching or instruction in any program/course will be carried out.
- ii. "Admission" shall mean enrolment of students under the various programs/courses offered by the constituent Institutes of the University from time to time.
- iii. "Candidate" shall mean a person who has applied for admission in the University in any of the program/course for the said academic year, and has been admitted provisionally.
- iv. **"Constituent Institutes"** shall include, all the institutes constituted by the University under the Gujarat Private University Act, 2009.
- v. **"Foreign candidates"** shall mean a person who does not hold an Indian Passport or is not a resident of India, but who wishes to seek admission in the University.
- vi. **"KSD"** shall mean Karnavati School of Dentistry, constituent Institute of Karnavati University.
- vii. **"Provisional Admission"** shall mean admission granted to a candidate provisionally in any program/course at the university, until his/her admission becomes final subject to the fulfillment of all the necessary requirements notified.

- viii. **"Provisional Admission Offer Letter"** shall mean the letter provided to the candidates confirming their provisional admission in the University in a specific program/course.
- ix. "Induction Letter" shall mean a letter issued to the candidate on fulfillment of the conditions listed in the provisional admission offer letter. The letter contains details of the program/course opted by the candidate, the date of commencement of classes and other information related to the same.
- x. "Qualifying Examination" shall mean passing of such examination which shall make a candidate eligible for the next higher class. For eg. 10+2, Bachelor's degree, masters degree, etc.
- xi. "Entrance test" shall mean a test undertaken by the Candidate at Central, State or University level for the purpose of securing admission in any Undergraduate/Graduate Level program/course offered by the University, it includes but is not limited to UGAT, KUAT, DAT, CLAT, IPMAT, JEE, NEET.
- xii. "Regulatory Authority" shall mean a body established by the Central/State Government for laying down the norms and conditions for ensuring academic standards of higher education, such as, UGC, AICTE, ACPC NCTE, MCI, DCI, BCI, PCI, NAAC, ICAR, DEC, CSIR, etc.
- xiii. **"Student"** shall mean a candidate admitted in any of the constituent Institutes in undergraduate, post –graduate, diploma, and research degree, PhD, of the University.
- xiv. "UID" shall mean Unitedworld Institute of Design, constituent Institute of Karnavati University.
- xv. "USCI" shall mean Unitedworld School of Computational Intelligence, a constituent Institute of Karnavati University.
- xvi. "USLM" shall mean Unitedworld School of Liberal Arts & Mass Communication, a constituent Institute of Karnavati University.
- xvii. "UWSB" shall mean Unitedworld School of Business, a constituent Institute of Karnavati University.
- xviii. "UWSL" shall mean Unitedworld School of Law, a constituent Institute of Karnavati University.
- xix. "University" shall mean Karnavati University at Gandhinagar, Gujarat.

4. Admission Procedure

4.1 Unitedworld Institute of Design (UID)

i. Eligibility –

- a. The candidate should be a law abiding citizen.
- b. Qualifying examination for Undergraduate Level Minimum 10+2 (higher secondary education in any stream) with minimum 50% [45% for SC/ST Candidates] aggregate score from any recognized higher secondary school board.
- c. Qualifying examination for Post Graduate Level Minimum 10+2+3/4 with minimum 50% [45% for SC/ST Candidates] aggregate score from any recognized Institute/University.
- d. The eligibility criteria shall be subject to change as per the directions of the regulatory authority.

ii. Application Process -

- a. The eligible candidates must fill and submit an Application Form for entrance test (Design Aptitude Test - DAT) along with the prescribed application fees to UID for admission at Undergraduate and Postgraduate Level. Mode (Online/Offline) of submission of application form shall be notified at the time of the release of the admission notification along with the last date of submission of the form and payment of the prescribed application fees.
- b. The application form for admission at UID shall be submitted on or before the last date of submission as per the notification. No form shall be entertained after the said last date.
- iii. **Selection Process** along with the Eligibility fulfillment mentioned in 4.1.i above, admission in UID at Undergraduate and postgraduate Level shall be subject to a Two-Tier Evaluation criteria. -
 - a. <u>Tier 1 UID DAT</u> (Design Aptitude Test) an entrance test of 100 marks,
 A merit list shall be prepared as per the cut off marks for shortlisting candidates for next tier evaluation criteria.
 - b. <u>Tier 2 Candidates</u> shortlisted from DAT, as per the merit list, shall be further called for Situation Test (ST) and Portfolio Evaluation (PE).

Dates for the UID DAT, ST and PE shall be notified to the candidates from time to time. The result of DAT shall be communicated to the candidates. The candidates eligible for ST and PE shall be intimated through an email.

The shortlisted candidates, after the second tier of evaluation criteria i.e. ST and PE, shall be issued a Provisional Admission Offer Letter, stating the conditions which are to be met to be able to secure a seat in the program/course opted by the candidate. On fulfillment of such conditions, the candidate's admission is confirmed and is offered an Induction letter.

iv. **Duration of Programs/courses** –

- a. Programs/courses at Undergraduate Level as prescribed by the concerned regulatory authority.
- b. Programs/courses at Postgraduate Level as prescribed by the concerned regulatory authority.

4.2 Unitedworld School of Law (UWSL)

i. Eligibility –

- a. The candidate should be a law abiding citizen.
- b. Undergraduate Level Minimum 10+2 (higher secondary education in any stream) with minimum 45% [40% for SC/ST Candidates] aggregate score from any recognized higher secondary school board.
- c. Postgraduate Level LLM Three or Five Year LL.B Degree from any Indian or Foreign University recognized by the UGC with at least 50% marks or equivalent grade [45% for SC/ST Candidates]. Candidates who have appeared for the final year LL.B examination may also apply.

The eligibility criteria shall be subject to change as per the directions of the regulatory authority.

ii. Application Process –

- a. The eligible candidates must fill and Submit an Application Form along with the prescribed application fees for admission at Undergraduate and Postgraduate at UWSL. Mode (Online/Offline) of submission of application form shall be notified at the time of the release of the admission notification along with the last date of submission of the form and payment of the prescribed application fees.
- b. The application form for admission at UWSL shall be submitted on or before
 the last date of submission as per the notification to the concerned institute i.e.,
 UWSL, no form shall be entertained after the said last date.

- iii. Selection Process along with the eligibility fulfillment, admission in UWSL at Undergraduate and postgraduate Level shall be subject to a Two-Tier Evaluation criteria. -
 - a. Tier 1 Karnavati University Admission Test (KUAT) an enterance test of 125 marks or CLAT Score. Admission shall be subject to the score obtained in the KUAT/CLAT.
 - b. Tier 2 The candidate shall be called further for Personal Interview (PI) on clearing the KUAT/CLAT.

Dates for the KUAT and PI shall be notified to the candidates from time to time. The cut off marks for CLAT and in case of KUAT the result, to become eligible for PI shall be communicated to all the candidates. The students eligible for PI shall be intimated through an email.

The shortlisted candidates, after the second tier of evaluation criteria i.e. PI, shall be issued a Provisional Admission Offer Letter, stating the conditions which are to be met to be able to secure a seat in the program/course opted by the candidate. On fulfillment of such conditions, the candidate's admission is confirmed and is offered an Induction letter.

iv. Duration of Programs/courses -

- a. Programs/courses at Undergraduate Level as prescribed by the concerned regulatory authority.
- b. Programs/courses at Postgraduate Level as prescribed by the concerned regulatory authority.

4.3 Unitedworld School of Business (UWSB)

i. Eligibility –

- a. The candidate should be a law abiding citizen.
- b. Undergraduate Level BBA (Hons.) Minimum 50% [45% for SC/ST Candidates] in 10+2 appeared/awaiting results from any recognized board in any stream.
- c. Post Graduate level The eligibility criteria shall be subject to change as per the directions of the regulatory authority.

ii. Application Process -

a. The eligible candidates must fill and Submit an Application Form along with the prescribed application fees for admission at Undergraduate and Postgraduate Level at UWSB. Mode (Online/Offline) of submission of application form shall be notified at the time of the release of the admission notification along with the

last date of submission of the form and payment of the prescribed application fees.

- b. The application form for admission at UWSB shall be submitted on or before the last date of submission as per the notification to the concerned institute i.e., UWSB, no form shall be entertained after the said last date
- iii. Selection Process along with the eligibility fulfillment, admission in UWSB at Undergraduate and Postgraduate Level shall be subject to a Two-Tier Evaluation criteria.
 - a. Tier 1 Karnavati University Admission Test (KUAT)- an entrance test of 125 marks or score obtained in UGAT / IPMAT shall be considered.
 - b. Tier 2- The selected Candidates from tier 1, shall be called for a Personal Interview (PI).

Dates for the UGAT/KUAT/IPMAT and PI shall be notified to the candidates from time to time. The cut off marks for UGAT/IPMAT and in case of KUAT the result, to become eligible for PI, shall be communicated to all the candidates. The candidates eligible for PI shall be intimated through an email.

The shortlisted candidates, after the tier - 2 of evaluation criteria i.e. PI, shall be issued a Provisional Admission Offer Letter, stating the conditions which are to be met to be able to secure a seat in the program/course opted by the candidate. On fulfillment of such conditions, the candidate's admission is confirmed and is offered an Induction letter.

iv. **Duration of Program** –

- a. Programs/courses at Undergraduate Level as prescribed by the concerned regulatory authority.
- b. Programs/courses at postgraduate Level as prescribed by the concerned regulatory authority.

4.4 Unitedworld School of Liberal Arts & Mass Communication (USLM)

i. Eligibility –

- a. The candidate should be a law abiding citizen.
- b. Undergraduate Level BA (Hons.) in Liberal Arts/Mass Communication and
 B.Com (Hons.) Minimum 50% [45% for SC/ST Candidates] 10+2
 appeared/awaiting results from any recognized board in any stream,
- c. The eligibility criteria shall be subject to change as per the directions of the regulatory authority.

ii. Application Process –

- a. The eligible candidates must fill and submit an Application Form along with the prescribed application fees for admission at Undergraduate Level at USLM. Mode (Online/Offline) of submission of application form shall be notified at the time of the release of the admission notification along with the last date of submission of the form and payment of the prescribed application fees.
- b. The application form for admission at USLM shall be submitted to the concerned institute i.e., USLM, no form shall be entertained after the said last date.
- iii. **Selection Process** along with the eligibility fulfillment, admission in USLM at Undergraduate shall be subject to a Two-Tier Evaluation criteria.
 - a. **Tier 1** Score obtained in Karnavati University Admission Test (KUAT)- an entrance test of 125 marks shall be considered.
 - b. **Tier 2-** The selected Candidates from tier 1, shall be called for a Personal Interview (PI).

Dates for the KUAT and PI shall be notified to the candidates from time to time. The result of KUAT to become eligible for PI, shall be communicated to all the candidates. The candidates eligible for PI shall be intimated through an email.

The shortlisted candidates, after the tier - 2 of evaluation criteria i.e. PI, shall be issued a Provisional Admission Offer Letter, stating the conditions which are to be met to be able to secure a seat in the program/course opted by the candidate. On fulfillment of such conditions, the candidate's admission is confirmed and is offered an Induction letter.

iv. **Duration of Program** –

a. Programs/Courses at Undergraduate Level – as prescribed by the concerned regulatory authority.

4.5 Karnavati School of Dentistry (KSD)

- i. Undergraduate program Bachelor of Dental Surgery (BDS)
 - a. **Eligibility** must be law abiding citizen
 - Must have completed the age of 17 years as on 31st December of the academic year for which admissions are being conducted,
 - Minimum of 50% marks (General Category)/45% (General PH Category)/40% (Reserved Category) in Physics, Chemistry and Biology (Theory + practicals) in 10+2 with B group or AB group from a recognized board, and
 - NEET Qualified

The eligibility criteria shall be subject to change as per the directions of the regulatory authority.

b. Procedure to apply - candidates are required to apply to the Admission Committee for *Professional UnderGraduate Medical Courses, Gandhinagar* in the prescribed format. The details of the same shall be published in leading newspapers in Gujarat along with on the website http://www.medadmgujarat.org/

ii. Postgraduate program - Master of Dental Surgery -

- a. Eligibility for admission in M.D.S. program/course shall be as per the rules and regulations of Admission Committee for Professional Post Graduate Medical Courses (ACPPGMEC), Gandhinagar.
- iii. Cancellation and Withdrawal of admission shall be as per the regulatory authority. The provisions and procedures for the refund of fees shall be regulated by the regulatory authority.

4.6 Unitedworld School of Computational Intelligence (USCI) –

 The eligibility criteria for candidates securing admission in the programs/ courses offered by USCI shall be as per the guidelines of the concerned regulatory authority.

5. Cancellation of admission and Refund of Fees (applicable to all constituent Institute of Karnavati University except KSD) -

- The constituent Institution shall notify the formal last date of admission and last date of cancellation/withdrawal of admission to the candidate in the Provisional Admission Offer Letter.
- ii. If the constituent Institute receives any request for cancellation/withdrawal of admission, after the formal last date cancellation/withdrawal of admission no refund shall be made.
- iii. The application for cancellation/withdrawal of admission should be communicated in writing to the Admission Department of the constituent Institute in such mode and manner as prescribed by the Institute from time to time, before or on the last date of cancellation/withdrawal of admission (before 5pm). No request shall be accepted for withdrawal of admission after the aforesaid dates.

- iv. In case, where the admission is canceled by the Institute, where the candidate has submitted false/forged/misleading documents or information, no fees shall be refunded.
- v. Provisions, if any, pertaining to any refund of fee shall be explicitly mentioned in the Provisional Admission Offer Letter.
- vi. In case a student of the University, wants to cancel their admission with the University at any later date, i.e., after the completion of admission process or semester, academic year, the student shall communicate the same to the University in writing; the University shall return the original documents of the student after they have obtained the NOC and cleared all the dues including the requisite fees.
- vii. In case a foreign candidate wishes to cancel or withdraw the admission with the University, he/she shall have to contact the Admissions Department of the Constituent Institute. The refund of the fees shall be as per the rules made by the University in this regard which shall be in accordance with guidelines issued by the regulatory authorities. The security deposits and the amount which is refundable shall be refunded to the foreign candidate.
- **6. Grounds for Deferral -** A student may seek deferral subject to the discretion of the University on a case to case basis.
- 7. No. of Candidate Intake(s) number of seats for the Undergraduate and Graduate Program/course shall be determined by the Board of Management in consultation with the Academic Council/relevant Institute/officers, authorities, bodies as the Board of Management considers appropriate as per the regulatory authorities. Such seats shall also be determined in accordance with the provisions of the regulatory body of a respective course and shall be notified at the beginning of every academic year.
- **8.** Conditions for Enrollment after the completion of the Selection Process the Candidate shall be given a provisional admission through issuance of a Provisional Admission Offer Letter, stating conditions, including verification of the original copies of credentials, which are to be met to secure a seat in the program/course opted by the candidate. The dates for the same shall be conveyed from time to time by the Institute. The conditions may vary from institute to institute and shall be mentioned in the Provisional Admission Offer Letter issued to the candidate.
- **9.** Payment of fees admission shall be confirmed only on the payment of the fees as mentioned in the Provisional Admission Offer Letter. The last date and mode for the

- payment of the fees shall be mentioned in the Provisional Admission Offer Letter. The fees for every particular program shall be notified at the beginning of the academic year subject to approval of the University and shall also be mentioned in the admission notification.
- **10. Attendance Requirement** The candidate has to satisfy the minimum attendance requirement of 75% attendance per semester, for the program/course in which he/she has been enrolled.

11. General Admission Guidelines -

- i. The candidates have to submit their required documents for the purpose of verification.
- ii. Requisite fees should be paid within the timeline announced at the time of admission.
- iii. OBC (Non Creamy Layer), SC/ST/PD candidates are required to furnish the certificates in the required format.
- iv. In case, the result of any qualifying examination is awaited, the candidate shall be admitted provisionally until the final results are submitted by the candidate. The last date for submission for such awaited results shall be determined and intimated for every academic year during the admission procedure.
- v. In case, any candidate wishes to change their branch/specialization after the commencement of the academic session, the request for the same shall be considered subject to the availability of the seat in such opted branch/specialization, after the payment of a one-time transfer fees which will be mentioned in the Provisional Admission Offer Letter.
- vi. The application for transfer of branch/specialization shall be made only before the examination for the First Semester. No requests to change branch/specialization shall be entertained thereafter.
- vii. The transfer to another branch/specialization will only be confirmed after the payment of the one-time transfer fees. The mode for application of the transfer shall be determined by the constituent Institute at the time of the admission process and shall be informed to the students.
- viii. Every candidate shall have to undertake to abide by the rules and regulations of the University, as issued from time to time.
- ix. University reserves the right to refuse enrolment to any candidate whose admission shall compromise the interest of the student community of the University.

- x. In case the student is unable to complete his/her program/course within the minimum amount of time required to complete the degree due to whatever reason, such student may be allowed an extension for 2 (two) years beyond the normal period to clear such a backlog to be qualified for such degree. Such students shall be treated as a private student and shall not be eligible for any ranking.
- xi. All the disputes and differences of any kind whatsoever, arising out of or in connection to the Provisional Admission Offer Letter, admission process, refund and cancellation shall be subject to the exclusive jurisdiction of the courts of Gandhinagar, Gujarat only.

12. Disqualification from Admission –

- i. The University reserves the right to cancel the admission of any candidate at any stage/time in case when the candidate does not fulfill the requisite conditions or fails to submit the required documents within the specified dates, or if the documents submitted by the candidate are found to be false/forged/misleading.
- ii. The candidate shall be disqualified from the admission procedure at the University/Constituent Institution in case he/she does not follow the rules of the University or violates the rules and regulations mentioned in the affidavits signed by the candidate at the time of the admission.
- iii. The University reserves the right to cancel the admission of the candidate in case the candidate fails to clear the qualifying examination.
- iv. Non-observance of any of the conditions mentioned in the Provisional Admission Offer Letter or violation of any of the rules, regulations, orders etc. of the University or its constituent Institutes shall lead to the termination/disqualification of the candidacy from the University.
- **13.** Lateral Entry Lateral entry admission shall be taken by the University/constituent Institutes, it shall be governed as per the concerned regulatory authority.
 - i. The eligibility and application procedure shall be mentioned in the Notification to be released by the University/constituent Institutes, which shall be in accordance with the guidelines of the regulatory authorities released from time to time (in case of absence of any such guideline the University reserves the right to decide its own eligibility criteria), on this behalf.
 - ii. The admission by way of Lateral Entry shall be taken when the same is approved by the Registrar.

14. Admission to Foreign Candidates –

- i. Candidates, citizens of foreign countries (outside India), who are availing admissions shall have to satisfy the eligibility criteria which shall be decided by the University in accordance with the guidelines issued by the regulatory bodies of the relevant program/course.
- ii. The admission of foreign candidates shall be subject to the fulfillment of all the conditions mentioned in the Provisional Admission Offer Letter and submission of all the proper documentations, VISA requirements and all other formalities as per the Indian law and the law of their respective country.
- iii. The admission process of the foreign candidates shall be facilitated by the education consultant or directly by the University.
- iv. To confirm admission with the University the foreign candidate shall have to make the requisite fee payment before the specified date, which shall be duly communicated to them.
- v. All the terms and conditions, rules and regulations governing the foreign candidate shall be mentioned in the Provisional Admission offer letter.
- vi. The foreign candidate shall agree to abide by the rules and regulations of the University and not indulge in any activity prohibited by the University.
- vii. In case a foreign candidate wishes to cancel or withdraw the admission with the University, he/she shall have to contact the Admissions office. The refund of the fees shall be as per the rules made by the University in this regard which shall be in accordance with guidelines issued by the regulatory authorities. The security deposits and the amount refundable shall be refunded to the foreign candidate.
- viii. The admission of the foreign candidate shall be canceled in case he/she submits any forged/false/misleading documents and in such case no refund shall be made.
- 15. Signing of Undertakings all the candidates seeking admission with the University shall submit the undertakings provided as Annexures below, duly filled and signed by the candidate at the time of admission to the concerned authority. Non-fulfilling of this requirement can lead to disqualification/ cancellation of admission. The parents of such candidates shall also have to fill, sign and submit the undertaking.

In case of any failure or default or ignorance on my part with regards to the adherence of the same, the University reserves the right to take any action against me and in such cases, I shall have no claim over refund of fee or otherwise against the University.
- 4. I agree that the University reserves the right to frame, amend, modify, revoke, repeal and enforce the Rules, Regulations, Policies, Guidelines, Ordinances as and when deem fit and it shall be my sole responsibility to keep myself updated with the same applicable from time to time, the University shall not be responsible for informing me separately in any manner.
- 5. The University reserves the right to introduce, alter or withdraw at any time, any program/course or facility and to revise the fees and other charges of the program/course or facility as deemed appropriate from time to time.
- 6. I shall be liable to pay for any damage caused by me to the property of the University either alone or jointly with others, apart from any disciplinary action(s) taken by the University against me.
- 7. I shall study at the University for the complete duration of the program/course and if due to any reason, I leave/withdraw at any time before the completion of program/course, I shall not be refunded any fees or other charges already paid, including security deposits, and the same shall be forfeited, and I shall be further liable to pay the fees and other charges for remaining/entire duration of the program/course.
