IPR CERTIFICATE COURSE

On the first day of the IPR certificate course, 22nd September, Dr. Nidhi Buch, Head of Centre for IPR & Assistant Professor (Law), Gujarat National Law University discussed the basics of Intellectual Property Rights, its significance and introduction to it. The second speaker for the day was Dr. Hardik Parikh, Assistant Professor (Law), Gujarat National Law University the students yet again were exposed to the concepts and learned about the IPR such as trademark, copyright – about its ownership, patent, novelty geographical indication, industrial design, trade secret as coca cola example. On the second day of the certificate course, 23rd September, 2022, Dr. Hardik Parikh, Assistant Professor, GNLU spoke on Industrial Designs and Semiconductor, integrated circuits, layout-designs and Trade secrets, Traditional Knowledge, Plant Varieties and Farmers rights.

On the third day of the IPR course, the first speaker was Ms. Shiva Mehta, Managing Associate at Y.J. Trivedi & Co took an interactive session on 'Filing Procedure of IPR'. She started with briefing the students on the basic concept of different kinds of Intellectual Property and then moved toward explaining the procedural requirements. The second session of the day was delivered by Mr. Anay Amin, Senior Associate & Attorney at Y.J. Trivedi & Co. The lecture was on 'Enforcement of Intellectual Property Rights'. The lecture went about an hour and gave the students an overview of the entire

concept. The third speaker for day was Dr. Annamma Samuel, DPIIT IPR Chair and Professor of Gujarat National Law University, who enlightened the students on elements of copyright, Doctrine of 'Scenes a Faire', economic and moral rights, performer's rights, licensing and assigning, and the different infringement remedies.

Dr. K.S. Kardam, Former Senior Joint Controller of Patents and Designs and Former Head, New Delhi Office took an interactive session on 'Law of Patents' for the students of United World School of Law, Karnavati University on 26th September, 2022. He started briefing the students with introductions on Patent, Intellectual output of Academia and Kinds of Intellectual Property Rights. Furthermore, the Historical Development of the Patent System in India from 1856 to 2005 was covered in detail.

On the fifth day, Adv Shobana Komal, Head IPR, Sricharan and Gowtham Law Chambers took a worthwhile session on the Law of Trademarks for the students of United World School of Law, Karnavati University on September 27, 2022. She gave a practical perspective to help the students relate to the subject well. Starting with an overview of IP law, she gradually delved deep into the topic of the law of trademarks.



GLOBAL ALUMNI LECTURE SERIES

Unitedworld School of Law through its Alumni Committee organized the Global Alumni Lecture Series. On 23rd September, 2022, our prestigious alumni Mr. Shanay Shah was invited to deliver a lecture on the topic 'Basics of Art of Mooting'. Dr. Shruti Chowdhary, Assistant Director, Alumni Relations of KU welcomed our prestigious Alumni emphasizing on the importance of Mooting and upcoming transition into the real world. Dr. Shruti Chowdhary explained that two elements are important to develop personal and professional relationships i.e. learning and networking. First, learning includes knowledge from lectures. To unlearn what you have learned and relearn the new things. Second, networking is branding yourself to others. Learning from the experience of others and then working smartly."

Our notable alumni, Mr. Shanay Shah, started the lecture and explained to the students that Mooting is the exposure the law school can give the students. That moot court is a depiction of what has actually happened. He then explained the fundamentals of Mooting i.e. approaching a moot problem and presentation in oral rounds. He explained to the students that the law is about knowledge, everyday learning new things. Mooting is not only about oratorical skills but also about research and discipline. He advised the students to bring out human or emotive elements in the mooting as well. Mr. Shanay Shah in the event, "Moot courts are presenting what is your understanding of the law is not communicating what the law is. The judges are going to back you in the corner; you are not going to let that happen. Moot courts are always chaotic. Don't assume it didn't go well. If you've given the answers, you're better than the opponent team."

Dr. Arun Kumar Singh (Assistant Dean UWSL) emphasized on taking the guidance from seniors as they are the best teachers. He gave students the Mantra of learning i.e. habit of learning, work hard and no shortcuts. Dr. Arun Kumar Singh in the event, "Winning is immaterial, interaction with the outside world will make you realize your position in the world."

In the closing ceremony Nishtha Agrawal (Assistant Professor of Law) gave a vote of thanks to our Alumni for sharing their knowledge and experience with the students.



Workshop on Commodities Derivative Market

A workshop was conducted on 10th September, 2022, for the 4th year and 5th year students on the topic "Understanding the Commodities derivative Market" by Ratnesh Mishra, Deputy Manager, NCDEX. His session was informative and the lecture started with the basic SEBI's regulations and then further the discussion went on to investing and how it is important and related to an individual. Also early investments give better returns because of compounding and growth of the company. If we see the society and their knowledge about investments, very less percentage of population knows about investments or does investments. Commodity is basically something which we get from nature and has a value. Commodities can be further

classified into investment commodities, consumption commodities, hard and soft commodities, agricultural and non agricultural commodities.

Later on the discussion moved into the market, factors determining demand and supply in the market. Then we discussed the evolution of commodity exchanges and how SEBI regulates the commodity derivative market. There are different types of derivatives such as forward, option, futures and swap. The discussion later was about the exchange of agricultural commodities. Then the risks of online trading were being discussed and how the dispute can be solved through ADR.
