Subject: Constitution of Anti Ragging Committee & Anti Ragging Squad - 2024

In pursuance to the guidelines issued by the University Grant Commission (UGC) to curb the menace of ragging and to ensure compliance with the provisions of the regulations as well as the provisions of any law for the time being in force concerning ragging; investigate complaints and also, monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution, the Anti-Ragging Committee is constituted by the Karnavati University.

The Anti-Ragging Committee is responsible for inculcating a culture of Ragging Free Environment on the Campus. It involves in designing strategies and action plan for curbing the menace of ragging in the college by adopting an array of activities. The committee is also responsible for conducting awareness programs from time-to-time on campus.

The term of the nominated members shall be for a period of one year or till further order, whichever is earlier.

The role & responsibility of Anti-Ragging Committee shall be as under;

- 1. To root out ragging in all its forms from the College by preventing its occurrence by following the provisions of these regulations and punishing those who indulge in the same despite of 'prohibition and prevention'.
- It shall consider the recommendations of the Anti-Ragging Squad and take appropriate decisions, including spelling out suitable punishments to those found guilty.



- 3. The Anti-Ragging Squad will have their visit, oversight and patrolling functions. It shall be kept mobile, alert and active at all the times and shall be empowered to inspect places of potential ragging and make surprise visit to the hostels, classrooms and buses. The squad investigate incidents of ragging and make recommendations to the Anti-Ragging Committee and shall work under the overall guidance.
- 4. The Anti-Ragging committee should be also review the efforts to publicize anti-ragging measures, cross-verify the receipt of undertaking from students and their parents / guardians every year and should facilitates the implementation of anti-ragging measures.

Duties and responsibilities of the Anti-Ragging Squad:

- To maintain vigil, oversight and patrolling functions and shall remain mobile alert and active at all times.
- To make surprise visits to the hostels and other places vulnerable to incidents and having the potential for ragging and shall inspect such places. In order to maintain effective vigilance, the Head of Squad may request in writing to the Chairman of the Anti-Ragging committee to add new members to the team, if need be.
- To conduct on the spot enquiry into any incident of ragging referred to it by the Head of the Institution or any member of the faculty or any member of the staff or any students or any parent or guardian or any employee of a service provider or by any other person, as the case may be.
- 4. Submit an enquiry report along with recommendation shall be submitted to the Anti-Ragging Committee for action provided that Anti-Ragging Squad had conducted such enquiry observing a fair and transparent procedure following the principles of Natural Justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incidents of ragging and consideration of such other relevant information as may be required.
